Challenges: BDCU must ensure uninterrupted access to financial systems to maintain customer trust and industry compliance. Its previous disaster recovery (DR) testing took 90 hours to restore a single virtual machine, far exceeding a 48 hour recovery time objective (RTO). For a community that needs quick, reliable access, this posed reputational and operational risks. And as a small institution, cost and scalability were also paramount.

Goals: BDCU aimed to transform its disaster recovery strategy by significantly reducing recovery times from days to hours and automating disaster recovery testing to ensure continuous backup integrity. The credit union sought a solution that could integrate seamlessly with its existing Wasabi Object Storage, avoiding the complexity and disruptions of switching providers. Additionally, BDCU prioritized aligning its disaster recovery processes with cybersecurity and compliance requirements through consistent, reliable reporting.
